Tax-deductible gifts can be made to the College via Americans for Oxford, Inc. (AFO). AFO has been determined by the United States Internal Revenue Services to qualify, under sections 501(c)(3) and 509(a) of the Internal Revenue Code, as a tax-exempt public charity to which tax-deductible contributions may be made.

To maintain the deductible status of gifts, US law requires that the Board of Directors retain control and discretion concerning grants to Oxford. Thus the wording used below. Whilst this phrasing is required legally, in practice the Board of Directors takes the wishes of the donor into full consideration. Receipts for donations are issued by AFO. Notification of gifts and disbursements to the Colleges are made quarterly. Your gift will be acknowledged as soon as we have received it, but this may be some time after your gift has been sent to AFO.
